### **INSIDE OUT REENTRY COMMUNITY**

Reentry case management is provided on-site and all the services of Inside Out - assistance with securing employment and permanent housing, getting ID's and insurance, access to behavioral and other health care, life skills classes and more -are available. Residents sign an agreement outlining expectations for living in and maintaining the house, including completing 6 hours of cleaning and maintenance each month. Page Street House meetings, Inside Out community meetings, and a volunteer mentor provide added support during your time in the house. On-going employment (to the extent able) and maintaining sobriety are required of all residents. Assistance is provided in securing permanent housing.

# COMFORTABLE, AFFORDABLE ACCOMMODATIONS

Each of the six residents has a private, furnished room as well as access to the fully furnished communal living areas in the house. There's off-street parking, and the large house has a deck in back and a small park across the street. While you're welcome to remain in the Reentry House for up to two years, the below-market rent (including utilities) allows you to save money for permanent housing when you're ready to move on. Rent will be \$500 per month with a \$150 refundable deposit due before moving in.



### **ARE YOU READY FOR CHANGE?**

Are you ready to make real changes in your life? If so, Inside Out Reentry Community's reentry house, called the Page Street House, in Iowa City may be just the place for you as you leave incarceration! The Page Street House is a sober living residence rooted in a common commitment to support one another in building healthy, fulfilling lives.





## WHO IS ELIGIBLE

The house serves low-income men who have been released from jail, prison or work release within the past 6 months and are returning to Johnson County. Applications may be submitted during the last 90 days of your incarceration or during the first six months after your release. Unfortunately due to federal funding, we cannot house people who have a lifetime sex offender registration requirement. Nor does the house meet the 2000 foot rule. However, everyone is eligible for and very welcome to participate in all other Inside Out programs. Please ask how we can assist you.



### **HOW TO APPLY**

Residents are accepted into the house on the basis of a written application and follow-up interview. If no room is available, eligible applicants will be added to the waiting list for 6 months or until a room becomes available. After 6 months applicants can update their information and reapply.
